2011-2012 Application for Contracted Ice

August 29, 2011 – June 21, 2012

Notes and Procedures

- The 2011-2012 Club Season will begin on Monday, August 29, 2011 and will end on Thursday, June 21, 2012.
 - Please note that this contract is binding for the entirety of the season and no provisions exist to refund or reduce costs for skaters who retire, relocate or suffer injury.
- Ice will be assigned according to the following priorities:
 1. Club membership seniority.
 2. Highest US Figure Skating Free Skating test passed (as of Monday, August 1, 2011).
 3. Date of application receipt.
- Applications not received by the Monday August 1, 2011 priority deadline will be processed in the order they are received and will not be granted the priorities outlined above.
- Applications submitted without the signature of the applicant (or, for minority-age participants, that of a parent or guardian) will not be processed and will be returned.
- Pairs must submit separate applications and clearly indicate which sessions they wish to contract for the purpose of skating as a pair.
- Once contracted ice has been assigned, skaters will have until Friday, September 16, 2011 to request changes (add/drop) to their schedule.
 - Sessions may be dropped, outright, until Friday, September 16, 2011. Skaters will not be permitted to drop sessions after that date and the contract will remain in force through occurrences of retirement, relocation or injury.
 - Skaters will still be responsible for sessions dropped during the add/drop period for the month of September.
 - Requested changes shall take effect on Saturday, October 1, 2011.
- All test requirements must be satisfied by the Monday, August 1, 2011 priority deadline.
 - The level designations for Moves in the Field sessions refer to the test level that a skater is currently working on.
 - The Ice Committee reserves the right to adjust a skater's schedule for reasons of improper test level.
 - Skaters passing a test that is beyond the designation of a session are strongly encouraged to move to an appropriate session if possible.
- Permanent Wait-Lists will be established for those sessions that are oversubscribed and skaters on the list will be granted an ordered priority above any walk-on skaters.
- The Ice Committee reserves the right to modify the schedule at its discretion.
 - Scheduled sessions may be cancelled to accommodate Club activities (including but not limited to test sessions, Ice Chips rehearsals, on-ice workshops and PSA or judging seminars).
 - Session designations or limits may be adjusted to ensure safety and/or maximize ice utilization.
- Please note that:
 - Subletting applications are available upon request in the Club Office.
 - Same-day switches from one session to another (of equal or lesser value) will be permitted if space is available. Sessions may be exchanged, within the same day, between family members.
- Skaters will be notified, in writing, of their assignments as soon as possible.
