2011 Winter Session Schedule & Application

December 5, 2011 – March 10, 2012

The fall session begins on Monday, December 5, 2011. Sessions will continue to be open to both members and non-members of The Skating Club of Boston. Members can contract ice at a rate of \$12 per session, and Non-Members at a rate of \$14 per session. Members may walk-on the session for \$15, while the walk-on rate for Non-Members will be \$17. Non-staff coaches may guest coach for a fee of \$5 per session, or for \$100 per season. Below is the Winter 2011 schedule:

Please note that the Monday 5:00-5:50pm Free Skate session will be shared with a **Basic Skills class area**. Therefore, this session will be best suited for working on isolated spins, etc. and not program runs. It is recommended that this session be used for low level skaters.

Application Notes and Procedures

- **LATE CHARGE PENALTY: All Contracts received after December 5, 2011, will be assessed a \$25.00 late processing fee.**
- Sessions are open to members of The Skating Club of Boston and non-members. (Non-members must show proof of U.S. Figure Skating Membership)
- Session level designated by Free Style level passed.
- Applications after the priority deadline of **November 28, 2011** will be processed, as they arrive, on a space-available basis (priority given to Members first) until the contract **application deadline of December 5, 2011**, after which the late charges penalty will apply.
- Applications without the signature of the applicant (or, for minority-age applicants, that of a parent or guardian) will not be processed and will be returned.
- Pair teams must submit separate applications and clearly indicate which sessions they wish to contract for the purpose of skating as a pair.
- **All skaters and coaches must abide by Ice Rules and Etiquette Policy (posted in the office)**
- Please note:
 - No refunds of deposits will be made after December 30, 2011
 - Resale of ice time is prohibited.
 - No cancellation of requested ice times will be considered after the priority deadline.
 - The Ice Committee reserves the right to cancel or modify any session.
 - **Same-day switches from one session to another are permitted if space is available.**
 - **Same-week switches from one session to another are permitted if space is available.**
 - **Half Sessions are only allowed if space is available for skaters whose school dismissal time and travel time has them arrive late for the 2:50 session Monday-Friday. Additional ice time thereafter must be purchased for an entire session. Half session (contracted or walk on) will be at the rate of \$7.50 for Members and \$8.50 for Non-Members.**
- **All applications must include a deposit of 50%, payable by cash, check (to 'The Skating Club of Boston'), or charge.**
